Unless specified, all quarantine / fumigation or storage charges where applicable are additional.

Local transport is quoted based on the use of standard flattop vehicles. Waiting time on vehicles held up whilst carrying your cargo can be subject to additional cost.

Customs duties / GST and ICS fees are additional to this quote if applicable.

All rates herein are for the carriage of general / in gauge cargo only unless otherwise specified.

Hazardous cargo is upon application, and is subject to acceptance and approval by destination agent and shipping line prior to acceptance of booking.

Volumetric charges may apply to your cargo depending on its nature. For airfreight 1cbm = 167kg. For seafreight LCL 1cbm = 1000kg.

All charges require receipt of payment prior to the cargo being delivered unless prior arrangements have been agreed to.

Additional services outside the normal customs clearance function shall be charged according to time and personnel required.

Our quotation is exclusive of GST to be incurred on taxable supplies, where applicable.

Cargo transit insurance is not included in our services unless specified. Therefore, unless we are otherwise instructed we understand that the responsibility of arranging insurance will be between your company and your insurer.

All rates / quotations are valid for 30 days from quotation date unless otherwise specified.
